Comments to the special items: 1. Data set: data base management and software: I am not quite certain, what the referee expects here. The data are now part of the PANGAEA data base. They provide the information for the reading and management of the data. The output “tab” files are ASCII and can be read by any editor or can be loaded into a software environment like MATLAB for further analysis. Is this the information which should be put into the manuscript? However, to fix the problem with an empty elevation column in the output files, we have to contact the PANGAEA support office, this goes beyond our scope. 2. Revise English: We tried to
